### April- June 2006 Training

#### Enrol Now

- **Supervisors and SHRs Training – Mon 15<sup>th</sup> to Fri 19<sup>th</sup> May 2006.** S1, S2, S3 (3 days) + Legislation (2 days). Three or five day training course. After additional workplace evidence is assessed a "Statement of Attainment" will be issued for: MNMG325A Apply risk management process, MNMG326A Conduct safety and health investigations, MNMG327A Communicate information and MNMMSU401A Apply...statutory / legal compliance.
- **Train the Risk Facilitator - Wed 7<sup>th</sup> to Fri 9<sup>th</sup> June 2006.** Three days skill development workshop. After additional workplace evidence is assessed a "Statement of Attainment" will be issued for the following two nationally accredited units: MNMMSG516A Facilitate the Risk Management Process and TAATAS504A Facilitate group processes.
- **Quarry Manager Training – Mon 19<sup>th</sup> to Fri 23<sup>rd</sup> June 2006.** Five one day Metalliferous Mining underpinning knowledge series (Law, Slopes, Transport/Infrastructure, Risk and Emergency) training courses (*part of the Diploma of Metalliferous Mining.*)

### RTO Developments

Two qualifications have recently added to Thrivability's scope.

They are:

- Certificate IV in Training & Assessment (from TAA04).
- Certificate III in Mine Emergency Response and Rescue (from MNM05)

Both of these require close cooperation with a client / partnering organisation. Note Thrivability will be running the emergency response training and assessment service out of North Queensland.

## *New Training Opportunities in WA!*

In newsletter #4 last year Thrivability announced three new training opportunities in WA. Two of them will be offered in the April to June period. "Train the Risk Facilitator" is a skills development course designed by Thrivability with the aim of increasing the standard of risk facilitation in the industry. Thrivability's director has been a risk facilitator since 1998 and has had a lot of experience both in Australia and Overseas. The second course is titled "Supervisors and Safety & Health Reps Training". This training is based on the popular Queensland S1, S2, S3 and Certificate IV level unit that covers legislation and the other skills attendees need to know to be effective in their roles in the workplace. Also note the promised "Advanced Risk Management" course for Registered Managers, Underground and Quarry Managers, Alternates, Deputy's and OH&S Managers is nearing completion and will be offered in July/August 2006.
