### Public Training Events May to June 2007

#### **Advanced Diploma Risk Cluster Training**

**May 7<sup>th</sup> to 11<sup>th</sup> 2007**

Five day (2x2.5 days) high level risk management training (for RM, QM, U/G Managers, Deputies and Alternates) based on two units from the Advanced Diploma MNM: MNMMSM617A Establish the risk management system. MNMMSM624A Establish and manage the mine OHS Management System.

#### **Certificate IV in Occupational Health and Safety**

**May 28<sup>th</sup> to 31<sup>st</sup> 2007**

Four day training block will provide underpinning knowledge (OHS Law, OHS Systems, OHS consultation and OHS risks) and simulated experience.

#### **Certificate IV in Metalliferous Mining Operations**

**June 5<sup>th</sup> to 8<sup>th</sup> 2007**

Four day training block will provide underpinning knowledge (Risk management, OHS investigations, communicate information and Environmental management systems) and simulated experience.

#### **Diploma of Metalliferous Mining**

**June 11<sup>th</sup> to 15<sup>th</sup> 2007**

Five day training block will provide underpinning knowledge for six units from the Diploma of Metalliferous Mining (Statutory / legal compliance, Stable mining systems, Production/Transport, Services/infrastructure, Risk management and Emergency management.)
