The Certificate IV in Metalliferous Mining Operations (Open Cut) has finally made it. In newsletter #7 Thrivability mentioned that contractors are the main takers for the Cert IV MNM for team leaders and supervisors, while this is still true the large mining companies have seen the light. TNLC Thrivability have recently completed a skill assessment process after a program of eleven days of training over a four month period, for a major mining company.
