Public Training Events Oct to Dec 2009 (see www.tnlc.com.au/events)

Certificate IV in Metalliferous Mining Operations (Perth)
Mon 26th to Fri 30th October 2009
Five units from the qualification: Statutory compliance, Apply and monitor systems for system mining, Report pit development, Managing blasting activities, Apply and monitor emergency preparedness.

S1, S2, S3 + Environmental Course (Perth)
Mon 9th Nov to Thurs 12th Nov 2009
This event consists of four one-day courses: MNMMEN503A Implement mining operations environmental systems; Communicate information (S3); Conduct safety and health investigations (S2); Apply risk management processes (S1).

Cover Story *Around for at least another 5 years*

Three important events have occurred since the last newsletter:

- (1) **RE-ACCREDITATION:** Thrivability have recently been re-accredited for the next 5 years up to 2014. We found the new audit process (outcomes based audit) to be far superior to the earlier process. After five years our understanding had probably also improved. Feedback from the auditor went along these lines: RTO well prepared and professional; No non-compliance found; Evidence returned to learner was good; Transition to RII09 going well; One of the best audits I (Auditor) have been involved with - things have been done not only for compliance purposes but for good business reasons.
- (2) **NEW SCOPE:** Thrivability Training & Coaching are now scoped for the new Resources and Infrastructure Industry Training Package (RII09). This package is a rationalisation of five other packages (Coal mining, Metalliferous mining, Extractive, Drilling, and Civil Construction) See adjacent RTO Developments column and our website for more detail. We are allowed to finish people enrolled in the MNM05 qualifications for up to 12 months. Next year all new training will be based on RII09.
- (3) **FRAGBLAST 9:** The papers delivered by TNL at the Fragblast 9 Conference were well received. The paper on electronic detonators by Dane Blair was of great interest and attendees were happy to do over-time (about 30 minutes) due to the amount of discussion stimulated.
