To be recognised using an RPL process the candidate will need to gather or develop evidence that covers the unit of competency performance criteria, and undertake an assessment of the required knowledge and performance evidence. For one or more units a Statement of Attainment will be issued and for a full qualification a "Record of Achievement" and the Advanced Diploma of Metalliferous Mining will be awarded. Note for selected units face to face training is available (RIIRIS601D, RIIWHS601D & RIIMEX602D).
