TNLC Thrivability Training and Coaching continue to offer training and assessment pathways for the BSB50420 Diploma of Leadership and Management. The new qualification requires 6 core and 6 elective units. TNLC offers 10 days face to face training and RPL for one unit and importing one RII unit. Note the qualification can also be undertaken by full RPL or assessment only pathway.

**Who should enrol?** The target audience for this new qualification includes: Department Managers, Superintendents, and Supervisors with more than 3 years at the supervisory level. Also direct entry is available to anybody with a Certificate IV in Frontline Management or Leadership and Management.

**Outcomes:**

On completion of the new qualification graduates will be able to display initiative and judgement in planning, organising, implementing and monitoring their own workload and the workload of others. They will use their communication skills to support individuals and teams to meet organisational or enterprise requirements. Graduates will be able to plan, design, apply and evaluate solutions to unpredictable problems, and identify, analyse and synthesise information from a variety of sources.
