In the mining industry this qualification is also suited for key Work Health and Safety Committee members including Managers, Superintendents and Committee Chairpersons etc.

On completion graduates will be able to use and maintain safety management systems, WHS tools and information systems, apply WHS risk management, manage hazards and apply occupational health principles, lead or participate in WHS investigations and manage effective consultative arrangements.
