This qualification can be undertaken in-house under contract, by full recognition of prior learning (RPL) or by an assessment only pathway using our sample of own work assessment toolkit (SWT).

Who should enrol?

This qualification is generally intended for line Managers, Superintendent and Supervisors who undertake audits as part of their job. It is also ideal for support staff in safety or training and other functions who are required to lead an audit or be part of an audit team. This skills development program complements skills such as facilitation, inspection and investigation.

Outcomes:

On completion graduates will be able to:

- Audit Integrated management systems such as WHS or HSEC as a team member
- Undertake layered audits of company systems, procedures and critical controls.
- Lead simple audits and as experience is accumulated lead more complex audit programs.
