**RII Training Package Processing – RPL Pathway [TOSIS5]**

TNLC Thrivability Training and Coaching is pleased to offer a Recognition of Prior Learning (RPL) service for two Processing qualifications. We have the capacity to work with potential candidates at both the RII40515 Certificate IV in Resource Processing level (12 units are required, 4 core and 8 electives) and RII50315 Diploma of Mineral Processing level (16 units are required, 8 core and 8 electives).

**Who should take advantage of this service?**

The Cert IV qualification has been designed for team leaders and supervisors working in the processing plant. The Diploma level qualification has been designed for senior supervisors (> 5 years) and superintendents / managers. Other factors such as time in industry, the possession of a Certificate III/IV in Resource Processing or other qualifications are also considered when applying for direct entry to the program. The Diploma of Mineral Processing program is tabulated below:
