This unit has been designed for senior supervisors (> 3 years as supervisor / coordinators) and superintendents. Other factors such as time in industry, the possession of a Cert IV SEO and other qualifications are also considered when applying for direct entry to the program. People from processing backgrounds will also be considered for this program.
