This qualification reflects the role of mineral processing facility line management who perform tasks involving a high level of autonomy and requiring the application of significant judgement in planning and determining the selection of equipment/ roles/ techniques for themselves and others. 13 units are required to achieve this qualification which involves a broad range of technical, managerial, coordination and planning and implement management plans.
