RII40320 Certificate IV in Underground Metalliferous Mining Operations – Training & Assessment Pathway

This qualification (RII40320) reflects the role of an Underground Mine Supervisor (Shift boss) in an underground metalliferous mine. They perform tasks involving a broad range of varied activities most of which are complex and non-routine. They are responsible for the quantity and quality of the output of others, contribute to the development of technical solutions to non-routine problems and apply mine plans to the workplace. Note, this qualification is not applicable to coal mines. The qualification is the minimum required training level to obtain an Underground Supervisor Ticket in NSW. The packaging rules require a total of 16 units, the 8 cores listed and 8 electives listed (other units available).

Who should enrol? This qualification is for people intending to become an Underground Supervisor. It is also applicable to individuals with operational experience in underground mining wishing to obtain the qualification. To be issued with a statutory (or practising) certificate you will need to comply with relevant State Resource Regulator (or equivalent).
