This qualification reflects the role of employees such as a Supervisor or Team leader in an underground metalliferous mine. They perform tasks involving a broad range of varied activities most of which are complex and non-routine. They are responsible for the quantity and quality of the output of others, contribute to the development of technical solutions to non-routine problems and apply mine management plans to the workplace. This qualification is not applicable to coal mining.

Other factors such as time in industry, the possession of a Certificate III in Underground Metalliferous Mining and other qualifications are also considered when applying for direct entry to the program.

Delivery format: Units are We run 13 of the above units two or three times per year and they can be completed in any order. People with a Cert IV in Frontline Management should not need to do any of the BSB units. Note it is possible to undertake different units for this program, however they will need to be completed by the RPL pathway.
