**Diploma of Leadership and Management Upgrade [TBSIS7]**

TNLC Thrivability Training and Coaching is pleased to offer an additional opportunity for our RI150115/RI150113/RI150109 Diploma of Surface Operations Management (DIP SOM) and BSB51107 Diploma of Management (DIP MAN) graduates. The Diploma of Management has recently been upgraded to BSB51915 Diploma of Leadership and Management, which now comprises 12 units. TNLC is offering an upgrade pathway for our DIP SOM and Double Diploma graduates. This requires candidates to complete and be deemed competent in 4 additional units (DIP MAN) or 7 additional units (DIP SOM) to qualify for the new DIP L&M qualification. Training is offered for five of these additional units as our DIP L&M Block 2, detailed in the tabulation below. Of the two outstanding units, one will be granted through RPL and one RII unit will be imported from the DIP SOM.

**Who should enrol?**

DIP SOM and Double Dip graduates wishing to take advantage of the opportunity to obtain a Diploma of Leadership and Management. Please note that we also offer the full Dip L&M for those who have not completed previous training with us (See TBSIS1).

**Outcomes:**

On completion of the new qualification graduates will be able to display initiative and judgement in planning, organising, implementing and monitoring their own workload and the workload of others. They will use their communication skills to support individuals and teams to meet organisational or enterprise requirements. Graduates will be able to plan, design, apply and evaluate solutions to unpredictable problems, and identify, analyse and synthesise information from a variety of sources.
